Shows/Exhibitions Policies

- Works must be original, thoroughly dry and ready for display. Artwork not properly prepared for showing may be declined. Two-dimensional art must be suitably framed and wired (no saw-tooth hangers) with wire ends taped. Wire, when pulled, must be at least three inches down from the center of the top of frame. Fasteners, such as screw eyes that hold wire, must be totally secure. Mats, glass or plexi-glass should be clean and not scratched or marred. Framed artworks 22 x 30 or larger must be framed with acrylic, not regular glass.
- All artworks must have been completed within past two (2) years. Works must be original, not a copy of another artist's work or from a magazine, book or photograph not originally taken by the artist or used without the permission of the photographer. No mechanical, giclee, laser or offset reproductions may be submitted other than original artist's prints submitted in printmaking media. CFABS may remove artworks that do not comply with copyright policy and if the artwork received an award, award may be revoked. Artwork that has been accepted & displayed in previous Center for the Arts exhibition within the last 4 months is ineligible. **Work created in classroom environment is eligible for submission. 'Student' must be designated on entry form.**
- The Center for the Arts of Bonita Springs reserves the right to decline artworks deemed inappropriate for display.
- CFABS occasionally photographs participant's and/or their artwork for use in its newsletters and publicity. Photos taken by the Center for the Arts become property of the Art Center and may be used in promotional materials now and in the future.
- All jury fees are non-refundable.
- Artists whose artworks have been declined in jury process will be telephoned. Declined artworks are usually available for pickup the Monday after receiving, 10 am to 12:30 pm. Artworks not picked up on assigned day will be subject to storage fee of \$5 per day per artwork. Late fees must be paid at time of pickup.
- A current CFABS membership card must be shown when entering artwork to receive the CFABS members' fee.
- Selected artworks will be hung using space available in the Main Gallery and the Tranovich Gallery. Award winners will be notified prior to the opening reception/awards ceremony. If the award winner is not present award money will be returned to the Shows & Exhibitions account for future shows.
- The Center for the Arts receives a commission of 35% on all artworks sold. Artworks, including those sold, must remain in place through the close of exhibition. NO EXCEPTIONS.
- Award winners are recorded throughout the year. As an artist triggers the threshold amount directed by the IRS for reporting, artist will be asked for his/her social security number so we may comply with IRS reporting requirements and issue 1099 form.
- Artworks must be picked up at close of each exhibition within the scheduled time stated in the show's prospectus. It is the responsibility of the artist to make necessary arrangements for pickup of artwork including written authorization for any person designated to pickup the artwork. Artworks not picked up on the day assigned will be subject to a storage fee of \$5 per day per artwork. Storage fees must be paid at time of pickup. CFABS is not responsible for the disposition of any artwork not picked up within one week of the scheduled pickup date and said artwork may be considered a donation to be used for fund raising. It is not the Center's policy to telephone artists to remind them to pickup their artworks. All reasonable care will be given to entries. Center for the Arts of Bonita Springs will not be responsible for loss or damage from any cause. **All work submitted is subject to these policies.**
